Happy New Year from the Orchard Heights Water Association! We hope 2016 is off to a good start for all our members and we hope you will take a moment to read this newsletter and get caught up with what is going on with OHWA.

Annual meeting held on November 10, 2015: The meeting was held at West Salem High School and board members presented an update on the activities of the association for the year, presented the budget, discussed planned incremental rate increases for 2016 and approved the number of shares for sale in 2016 as well. Board members were voted on with Jennifer Meltzer, Steve Riley and Clara Taylor agreeing to finish out their current two-year terms and Gillian Fischer stepping forward to fill one of the two vacant positions on the board. We expressed our appreciation to Leo Woods and Teresa Hire for their time served on the board.

Annual Back-Flow Testing: As mentioned previously, in order to meet the requirements of the State of Oregon, we are required to make sure all cross connections to our water main have an approved backflow or other cross-connection device that protects our water supply from potentially harmful contamination. We must submit a report to the State annually verifying that each service on the system has performed and passed the testing. Our policy requires that each member of the Association submit their test report by Sept 30 of the calendar year. If you have already arranged for testing and submitted your test report for 2016, then you are well ahead of the curve and we thank you. However, most of the membership will not have gotten this accomplished yet and we want this to serve as a reminder and also to let you know that the board is going to be considering whether to hire a testing service to perform all the back-flow testing for OHWA and just bill each member of the Association annually for this service. We will keep the membership posted if the process changes. Need to fill vacancy on the Board: We still have one vacancy on the OHWA board of directors. We really need a volunteer from our membership to serve.
